Exhibitor will abide by and be subject to the following agreement as a condition for acceptance as an exhibitor at the Boca Strawberry Festival.

- 1. All items to be displayed at my booth at Boca Strawberry Festival are the same as what was submitted for jurying. I agree that the photos submitted may be used for promotional purposes.
- 2. I will not sublet booth space.
- 3. I understand that I must bring my own set up tent, tables, chairs, decorations, etc. I also understand that I must secure my tent with weights, such as blocks, sandbags, or barrels of water. Please make sure weights are heavy enough to withstand strong winds. Stakes are not allowed. A fine of \$500 will be assessed to any exhibitor with tent staked. This is done to avoid staking the water or electricity lines.
- 4. I understand that the promoter reserves the right to remove, without refund or recourse, any exhibitor who misrepresents himself or his product.
- 5. I agree to comply with all local and state regulations. I will have no open flames unless I receive written permission in advance of the show.
- 6. I will obtain all tax, vendor, or other permits as required by local or state authorities at my own expense.
- 7. I understand that sale signs are prohibited and that I must store excess stock out of sight, and that I agree to abide by move-in and move-out regulations as stipulated by the promoter. I further agree to remain set up for the duration of the show.
- 8. My initial payment represents a commitment to show. Once accepted, I understand that any exhibitor who fails to appear one hour before show opening forfeits his right to exhibit without refund or recourse.
- 9. Insurance Certificates are requested by both Artisan Promotions and City of Boca Raton as named insureds on your insurance policy. There should be no charge for this, it is normally a free service from your insurance company. If you need to contact a company to buy an insurance policy. Here is a company that is used by many artisans: www.app.actinsurance.com They sell a 3-day policy for about \$50.

Whatever amounts your policy covers should be sufficient.

And shall be held harmless from any manner of action, suits or claims. Insurance for such loss, damages or injury will be my sole responsibility.

- 11. If my check is returned due to insufficient funds, I agree to pay a \$35 service charge and replace it with a money order or teller's check, or to forfeit my place at the Boca Strawberry Festival.
- 12. It is agreed that Artisan Promotions, Inc. reserves the right to amend and/or add to the applicable rules pertaining to and governing this show at any time prior to the commencement of said show. Additions or amendments will be circulated to exhibitors in writing. The interpretation of all rules by the promoters shall be final.
- 13. Any requests for refunds must be done in writing. There will be a \$50 processing fee for cancellation before December 1st. There are no refunds after this date.
